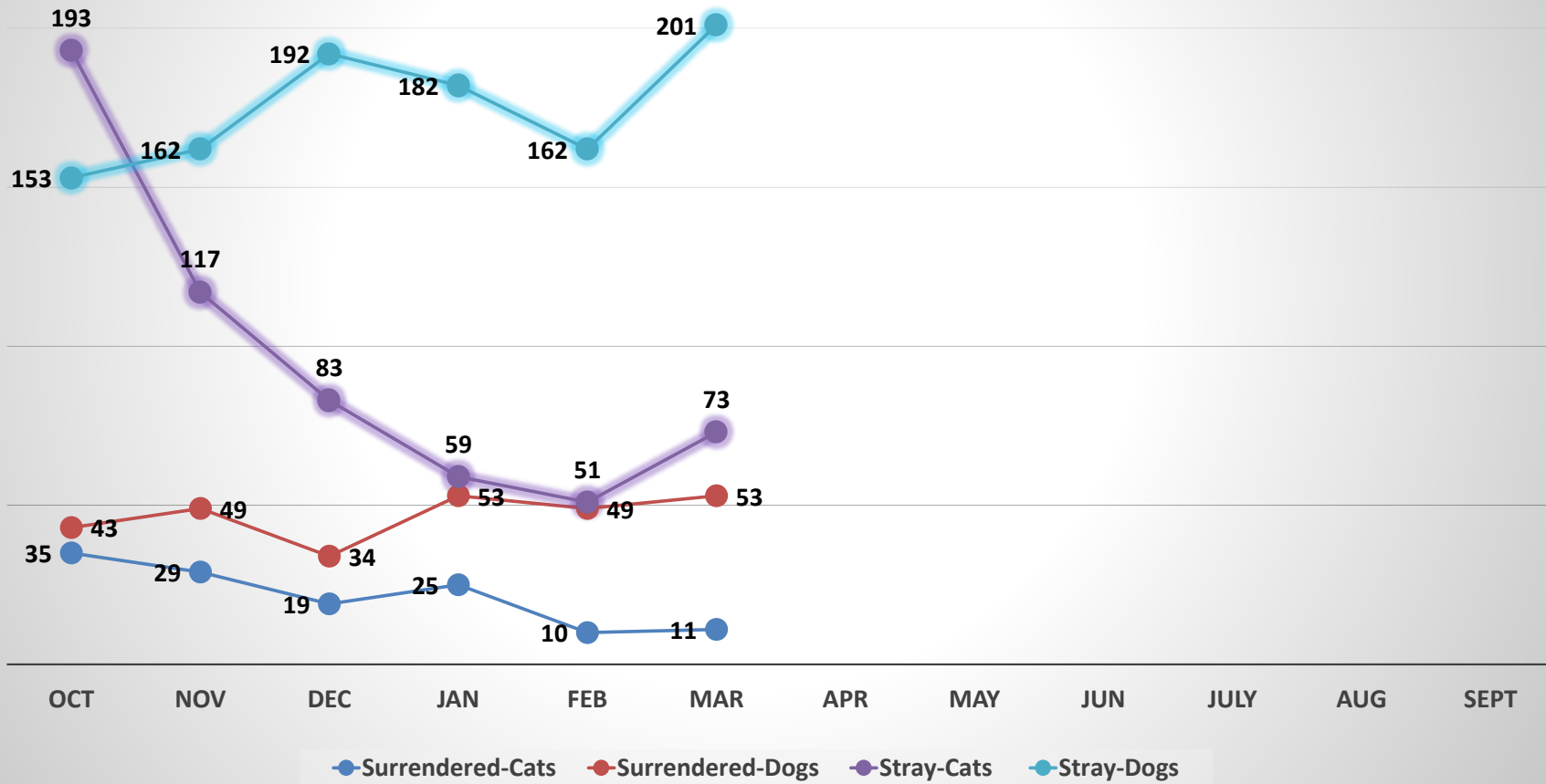

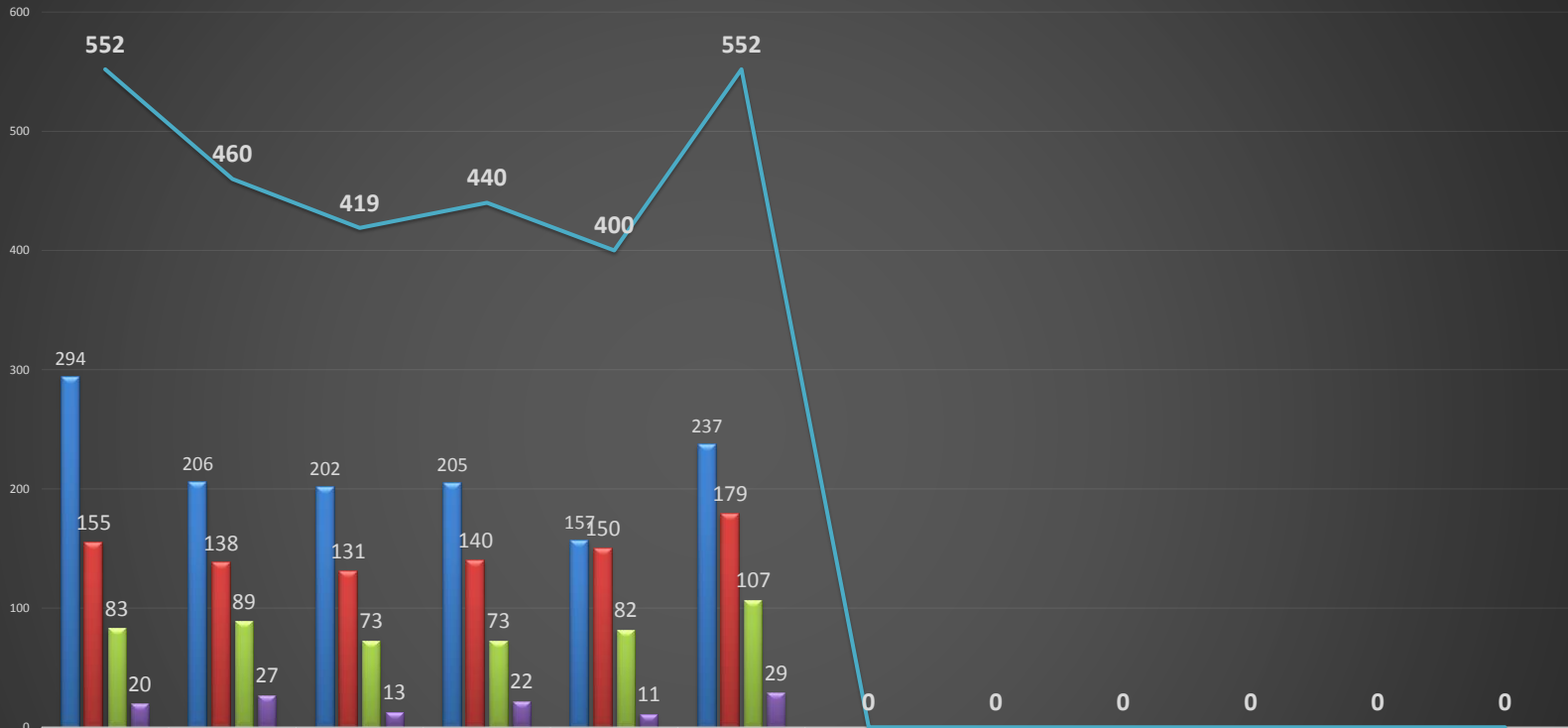


San Marcos Animal Services FY17 Intake - Stray vs. Owner Surrender

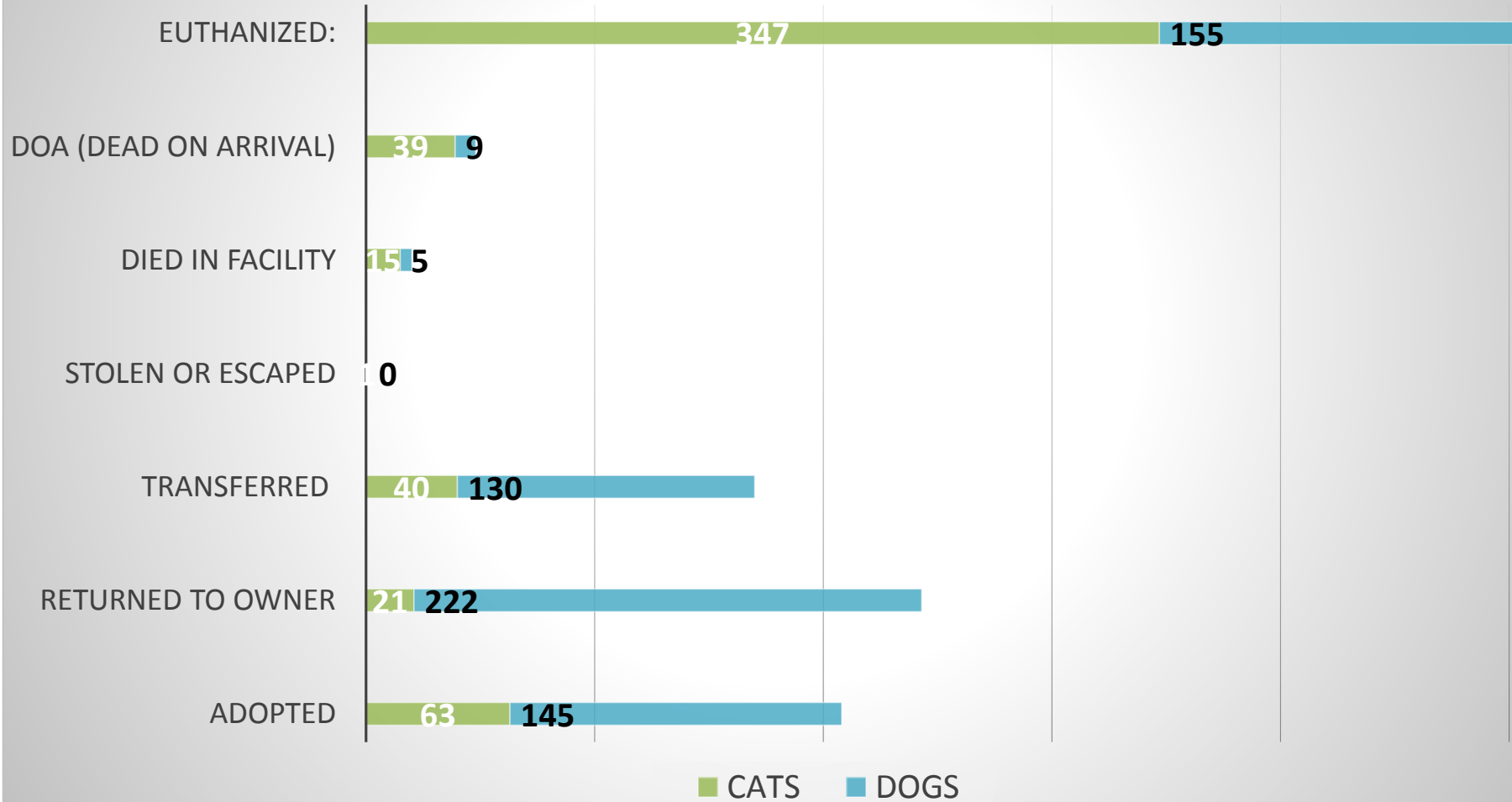
